

Aquaculture in Ohio

- The 1998 Census of Aquaculture
 - 33 fish farms in Ohio
 - \$1,788,000 in total sales
- 2005 Census of Aquaculture
 - 55 fish farms
 - sales of over 3.2



- total aquaculture sales increased at a rate of 17% per year
- aquaculture ranked 15th in Ohio for value of agriculture products sold







Most farms are small

- 75% Farms are family operations
- 87% Not primary source of income
- 37% Food fish, 34% game fish, 21% fingerlings
- 66% ponds, 43% tanks, 13% cages
- YP 35%, RT 33%, LMB 29%, BG 29%, CCF 24%, Minnows 19%
- 57% market to pond owners, 32% direct retail





Rules and Regulations

- Aquaculture is a form of agriculture in Ohio
 - Ohio Revised Code 1.61. "Agriculture" defined.
- Aquaculture permits in Ohio
 - Ohio Department of Natural Resources
 - Fee: \$50.00 \$100.00 annually

- Fish Importation into Ohio
 - Aquatic fish health is regulated by the Ohio Department of Agriculture

- Storm Water Discharge permits Notice of Intent (NOI)
 - Ohio EPA
 - Fee: \$200.00 \$500.00
 - those construction activities (including pond building) involving 1 or more acres of land disturbance.

- National Pollutant Discharge Elimination System (NPDES) permits
 - Ohio EPA
 - applies to commercial (for profit) and non-commercial facilities that produce, hold or contain 100,000 pounds or more of aquatic animals per year...."

- Water Withdrawal Facilities Registration
 - Ohio Department of Natural Resources
 - > 100,000 gallons/day

- You must think about becoming vertically integrated (hatching to marketing)
- You must think about adding value
 - Niche markets
 - Processing
 - Agritainment
 - High value species







Economic Considerations

- Do you have a business plan?
- Do you own property that is suitable?
- Capital
 - Facility construction
 - Equipment costs
 - Labor
 - Insurance
 - The unexpected





Economic Considerations

- Does your lender understand aquaculture?
- Can you wait 12-18 months for first crop?
- Can you wait five years to make a profit?
- Is profit higher than other investments?





Personal Considerations

- Work long, hard, irregular hours?
- Good with people? (clients, labor)
- Good with math?
- Good with carpentry, plumbing, electric?
- Good at learning new things?
- Good at asking for help?
- Internet savvy?





Marketing Considerations

- Have you assessed the market?
 - Year round or seasonal
 - More than one?
- Can you compete?
- Will your product be processed?
- Product transportation, holding?
- Legal issues regarding marketing?





Site Considerations

- Site restrictions
 - Zoning & Wetlands
 - Year round access, large truck access
- Expansion
- Biosecurity
 - Humans, birds, disease
- Water
 - Volume, Quality, Conservation & Control
- Waste management
- Dependable utilities (back up system)





Socio-legal considerations

- Neighbor relations
- State agencies
 - ODNR, DOAg, OEPA, OSUE, Sea Grant
- Permits
- Laws





Production Considerations

- Species selection (biology, market)
- Production technologies (pond, indoor)
- Sources
 - Fish, fingerlings, feed, chemicals, equipment, information, advice.
- Disease diagnostics
- Dependable labor


